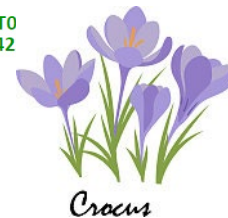

FEDERAL FUEL CHARGE INCREASE

The Federal Fuel Charge (Carbon Tax) will increase on April 1, 2024 from \$3.33/GJ to \$4.10/GJ.

Federal Fuel Charge Increase

Carbon Levy Impact

Effective April 1, 2024

This charge will increase to \$4.10/GJ

The current price of \$65 per tonne (of carbon dioxide equivalent (CO₂e) emissions) for heating fuels will increase on April 1, 2024 to \$80 per tonne. These rates are prescribed by the Government of Canada on an increasing scale and are scheduled to increase to \$95 per tonne in April 2025.

Natural Gas Utilities are required to charge these rates as per the federal *Greenhouse Gas Pollution Pricing Act*. All fees charged under this Act are remitted directly to Revenue Canada.

The new rate will be automatically applied to your bill for natural gas consumed beginning April 1, 2024.
