ANNUAL METER CHANGES/RECERTIFICATIONS

Our field staff are preparing for the upcoming 2025-meter changes.

Replacing the natural gas meter at your property is a Measurement Canada requirement. Our office or field staff will be in contact via email or phone to advise when they will be in your area. Please update our office with any new phone numbers or email addresses for customer communication if you haven't already.

FEDERAL FUEL CHARGE REMOVAL

The federal fuel charge will no longer apply to natural gas consumed after March 31, 2025. However, depending on your utility's billing cycle, your April bill may still include these charges for natural gas used in March. Only natural gas consumed on or after April 1 will be exempt from the federal fuel charge.

Carbon Levy REMOVAL

Effective April 1, 2025

This charge will be **removed**

On March 15, 2025, the Government of Canada announced that it will be removing the Federal Fuel Charge.

Your Natural Gas Utility will no longer be required to report on or pay the charge for all types of fuel, including marketable natural gas, consumed after March 31, 2025.
